Policy on **WBP membership**

Membership becomes valid when payment is received by ACI EUROPE. Any member joining during the course of the year will be invoiced for a full first year, pro rata in year two, and thereafter annually on 1 January. To cancel membership, ACI EUROPE must be notified in writing no later than 30 November of a given year and the cancellation will take effect on 1 January of the following calendar year.
